**President's Message - Geertje Boschma**

CAHN/ACHN was founded in 1987 and celebrates its 20th Anniversary this year. A first conference was held in 1988. The upcoming 2008 CAHN/ACHN International Nursing History conference, to be held at the University of Toronto Faculty of Nursing, will mark twenty years of an organized effort to stimulate interest in the history of nursing, endorse preservation of historical material, promote historical nursing scholarship, and encourage students in their study of the history of nursing as outlined in the objectives of our organization. As noted in the conference call, the conference brings together scholars from many different countries and many different areas of nursing and health care history. The conference theme, *Borders, boundaries and political context in health care history*, indicates a view of history that contributes to a critical understanding of developments and events that shaped nursing and health care. The conference themes explore and raise critical questions about the social and power relations that affect health care.

Being a relatively small, charitable volunteer organization, it takes the work of many to make this broad aim happen, and we are fortunate that we have been successful over the years to continue to attract people to our group who have given their time and commitment to strive toward the realization of CAHN/ACHN's objectives. Members of our organization have been involved in building connections and continue to be involved in initiatives that foster expanded interest in the field. Looking back at the conferences over the last years, we have seen a gradual expansion in the number of students presenting new research, supported by a growing number of scholars engaged in historical research in nursing. Also, we have maintained a membership of interested nurses dedicated to promoting and preserving the history of nursing. The CNA has requested our input in updating the CNA Position Statement Promoting Nursing History/La mise en valeur de l'histoire des soins infirmiers which was first developed with our input in 2004. The CNA centennial celebration, also in June 2008, has sparked the interest in updating the statement.

Over the years, we have built connections with related fields, resulting in several joint conferences with our colleagues in the history of medicine, and continued connections and activities with women's history scholars. Vera Roberts, one of our more quiet, but committed members made CAHN/ACHN a beneficiary of her will with a large endowment, with the specific aim to promote the history of northern nursing, preferably of the circumpolar area. We will promote the interest in this area of scholarship at the upcoming conference with a panel of presentations devoted to historical research.

We continue to benefit from ongoing support of AMS in funding of an annual Hannah Lecture and over the last years an amount of funding for student travel. For the upcoming conference we have received a substantive AMS conference grant toward the cost of the conference to reach our goal of an international conference, as well as support from various other sponsors. We invite you all to attend our upcoming conference and to encourage others to come as well. We will have several francophone speakers, so - repeating Anne-Marie Arsenault's earlier invitation: Je lance une invitation spéciale à nos collègues francophones du Québec et des autres régions canadiennes de se joindre à nous en devenant membre de l'Association. Nous souhaitons une grande participation aux activités planifiées pour la prochaine année.

Last May we had a very successful joint conference with the Canadian Society for the History of Medicine. The Hannah Lecture was presented by Dr. Maureen Lux. Several students presented their research as well as a large group of nursing and medical history scholars. Many outstanding new books in nursing history were presented at a book launch and

conference reception, hosted by Dr. Jacqie Duffin, and we enjoyed a pleasurable conference dinner. We thank Sandra Bassendowski for taking on the local arrangements, together with Barry Edginton and Lisa Smith. During the Annual General Meeting we approved of the proposed changes to our constitution and bylaws, as distributed among our membership in March 2007, including two friendly amendments that Associate members may also hold offices at the discretion of the executive and that the membership committee shall be composed of up to two members, at least one of whom will be a regular member of the Association, with term of office of two years, which can be renewed. The scholarship awards were announced, and you will find them reported in the newsletter. Last, but not least, we welcome several new and many continuing members on the board and standing committees to take up the work of the organization. I am looking forward to working with all of you in my new role as president over the coming years. And I hope to meet many of our members at the upcoming conference.

## **CAHN/ACHN Scholarship & Research Awards Committee**

### **CAHN/ACHN Dr. Allemang Scholarship in Nursing History (2007)**

The committee received several excellent submissions for the scholarship. We awarded one scholarship at the master's and one at the doctoral level. Congratulations to both recipients.

Master's Level Scholarship: Shaina Goudie from Memorial University, NL studying the changes in nursing education in Newfoundland after 1966—the year that the Memorial University Bachelor of Nursing program was founded.

Doctoral Level Scholarship: Mary Jane McCallum from the University of MB studying the Aboriginal nurse history in Canada during three periods: 1900-1945, 1950s and 1960s, and 1969-1989.

### **Vera Roberts Endowment (2007)**

Besides funding research in northern nursing, publication/dissemination of northern nursing history may also be funded. The committee has developed some guidelines for this avenue; the guidelines for research and publication proposals can be found on the cahn-achn website.

The scope of eligible projects for the publication (dissemination) of northern nursing history is broad. Some possible projects may include:

- An exhibit on northern nursing
- A presentation to a historical or nursing conference
- A CAHN/ACHN lecturer or invited speaker at a conference
- A northern panel for nursing history at a conference
- Preservation of primary data
- Collection or compilation of primary data, for example oral histories

Interested applicants may contact the chair of the Scholarship and Awards committee to ascertain the appropriateness and fit of a proposal project. The principle investigator/disseminator should write a letter to the chair outlining the proposed project including time lines and budget. The “Application Cover Page” from the Guide for Nursing History Proposals may be used where applicable.

The committee received an application from the organizers of the CAHN/ACHN Conference Planning Committee (2008) to fund a panel of northern nursing history. The project which includes a bi-lingual panel of four nursing history scholars has been awarded the first monies from the Vera Roberts Endowment.

# CAHN/ACHN International Nursing History Research Conference

## Call for Abstracts:

### **Borders, boundaries and political context in nursing and health care history**

The conference is organized by the Canadian Association for the History of Nursing/Association Canadienne pour l'Histoire du Nursing and co-sponsored by the Associated Medical Services, the Faculty of Nursing, University of Toronto, the School of Nursing, Ryerson University, the School of Women's Studies, York University, the Allemang Centre for the History of Nursing, and the AMS Nursing History Research Unit.

Aiming for a critical understanding of connections between health and nursing, the conference welcomes papers that explore borders, boundaries and the political context in nursing and health care history. The conference seeks to explore the history of nursing practice, religious and missionary roots of modern nursing, as well as critical questions on the history of specialty areas and regions of practice. Looking at critical and under-examined areas of nursing's past, questions of practice, power and health policy will be examined. How did local, regional and global contexts of health care shape nursing practice? How did colonial, imperial and political regimes impact on health care practice and administration? How did communities respond to special needs, difficult behaviour and vulnerability? How did nurses influence or participate in (inter) national health politics? What tensions arose over claims of knowledge, skill and identity? Priority will be given to abstracts addressing these themes.

The conference brings together scholars from many different countries and many different areas of nursing and health care history. We especially welcome abstracts from students. CAHN/ACHN has a certain amount of funding to support student travel. The two Hannah Lecturers at the conference will be

Karen Schultheiss, Assistant Professor of History at the University of Illinois, Chicago, author of *Bodies and Souls: Politics and the Professionalization of Nursing in France 1880-1922*.

Catherine Choy, Associate Professor of Ethnic Studies at the University of California Berkeley, author of *Empire of Care: Nursing and Migration in Filipino American History*.

Please submit a one page abstract on completed research by e-mail of no more than 300 words. State the title of the paper at the top and at the end list name, institutional affiliation or city, contact information, and whether you are a student. Let us know if you would like your e-mail to be published along with the abstract, and if you have any audiovisual or other special requirements. Abstracts will be peer-reviewed.

## 2007 CSHM/CAHN Joint Conference—Hannah Lecture

The following is the abstract for the Hannah Lecture presented by Dr. Maureen K. Lux, PhD Department of History, Brock University at the Joint CSHM/CAHN Conference held in Saskatoon May 31—June 2, 2007.

### **“Segregated and Isolated: Institutional Health Care for Aboriginal People in Post-World War II Canada”**

The Charles Camsell Indian Hospital in Edmonton was officially opened in August 1946 by Governor General Field Marshall Viscount Alexander of Tunis. Eight-year-old patient Doreen Callihoo quietly presented Lady Alexander with a bouquet of flowers. It was high state drama intended to signal the arrival of modern and effective health care for Aboriginal people. For forty years from 1945 to 1985 the hospital, with more than 500 beds, treated First Nations and Inuit people from the west and north. It was part of a larger expansion of hospital spaces for Aboriginal people; by 1960 the government owned twenty-two racially-segregated hospitals of varying size. Bureaucratic, medical, and to a certain extent, historical discourse suggests that hospitalization was part of a natural progression toward effective health care that most Canadians already enjoyed. But large-scale hospitalization must be seen as historically contingent. Institutions for Aboriginal people might be seen in light of the international literature on modern institutions of isolation and confinement – the hospital, the penitentiary, the residential school. In the post-war era the emerging Canadian welfare state was increasingly committed to the management of those who needed care or control. Aboriginal tuberculosis sufferers and those assumed to be ‘carriers’ of the disease could not be trusted with the freedoms that healthy and responsible citizens enjoyed. The threat to the public health of the careless infected justified their incarceration as a service to the wider community. The hospital’s opening ceremony as one of the first acts of the newly-established department of National Health and Welfare, the flagship of Canada’s welfare state, was a very public demonstration of the state’s commitment to protect all Canadians by segregating and isolating those who threatened the public’s health.

## **Tribute to Anne-Marie Arseneault**

Anne-Marie completed her term as Past President of the Canadian Association for the History of Nursing in June. As she leaves the executive I would like to pay tribute to her accomplishments and the leadership she provided to the Association. She was present at the founding of CAHN and brought a unique perspective during her years on the executive.

Anne-Marie has been a devoted advocate of bilingualism and has often translated or contributed to the translation into French of a variety of CAHN documents, always on a voluntary basis. Her efforts and skill in this area have contributed to understanding and appreciation between anglophone and francophone nurses. In 2006 Anne-Marie and Member-at-Large Nicole Rosseau worked with a translator to have the Vera Roberts Endowment application and forms made available in French. This is a significant accomplishment as it broadens the range of potential applicants for this award. A proper translation is not easy, at times, even for professional translators. Anne-Marie and Nicole devoted the time and energy needed to see that a French version of the original is correct and clear.

From 2003 to 2005 Anne-Marie was the President of CAHN. During this time she ensured the Association would meet the terms of Vera Roberts' will and received the funds bequeathed to CAHN. This was a milestone for the Association as it is the first time an endowment has been given to the Association. In addition to working to develop the Association's capacity to grant awards, Anne-Marie worked with the Canadian Nurses Association to develop the Position Statement on History of Nursing. The Statement provides an articulation of the importance of nursing history for nursing educators and others. In bringing these initiatives to fruition, Anne-Marie was an able negotiator for our Association's objectives.

Working with Anne-Marie is a pleasurable experience; she is a patient teacher who builds on the strengths of the people with whom she works and fosters a sense of shared accomplishment – building a cohesive sense of teamwork. CAHN has been fortunate to have had the benefits of her knowledge and skill.

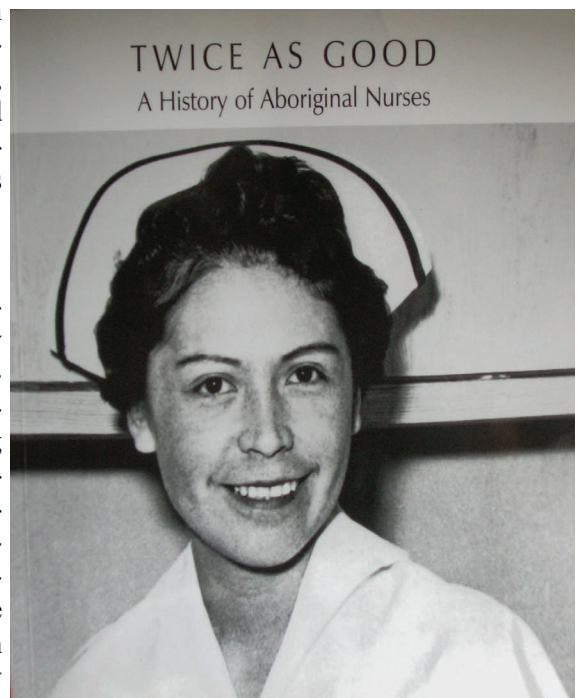
***Twice As Good: A History of Aboriginal Nurses***  
**Aboriginal Nurses Association of Canada, Ottawa, 2007**  
**Mary Jane McCallum**

*Twice As Good: A History of Aboriginal Nurses* uses the records of the Aboriginal Nurses Association of Canada (ANAC) and the National Archives of Canada, as well as a range of secondary literature and the recollections of several Aboriginal nurses to examine a century of Aboriginal nursing history in Canada. It has three main goals. First, it attempts to dispel the myth that the retention and recruitment of Aboriginal nurses is a 'new' or 'recent' crisis by providing a loose chronology of four main periods of Aboriginal education and employment in the nursing field (1900-1945; 1945-1969; 1969-1989 and 1989-2006). Second, it argues that Aboriginal nurses stood at a number of critical intersections of Canadian and Aboriginal politics, Indian and health policy, and "Western" and "Traditional" practice and can therefore tell us much about the history of Aboriginal health, Aboriginal labour and the history of nursing in Canada. Third, *Twice As Good* endeavours to open up a long and interesting history of Aboriginal nursing's past to all Aboriginal students, including nurses. It is intended for those interested in both teaching and learning about the history of nursing, Aboriginal education, and Aboriginal labour. *Twice As Good* is available through the Aboriginal Nurses Association of Canada at [www.anac.on.ca/publications.html](http://www.anac.on.ca/publications.html).

*Twice As Good* began as part of my doctoral work at the History department at the University of Manitoba. After sharing a paper on the history of Aboriginal nurses with the ANAC executive, I was asked to do a larger project on the history of Aboriginal nurses. As an Aboriginal student, I have a vested interest in the experiences and policies guiding post-secondary education for Aboriginal students, and have noted a distinct lack of information about the history of Aboriginal people in post-secondary education and work. The book is an attempt to delve into issues of access to higher education, the employment patterns of the Medical Services Branch (now First Nations and Inuit Health Branch), the association of nursing and health with decolonization, and the promotion of cultural competency in nursing education and work. I have greatly appreciated the support of the ANAC, as well as CAHN-ACHN, through its Allemang Scholarship.



*My name is Mary Jane McCallum, and I am a history student at the University of Manitoba. I study, in part, the history of Aboriginal nurses in Canada, and I received CAHN's Allemang scholarship this spring. I wrote a brief history of Aboriginal Nurses for the Aboriginal Nurses Association of Canada, which has been recently printed into a booklet.*
