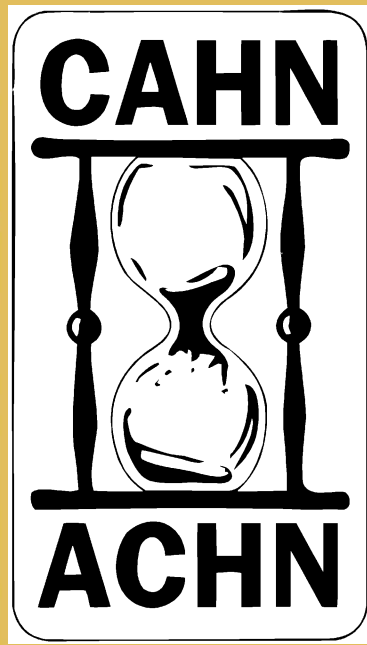

## President's Message – Dr. Margaret Scaia



First, thank you all for your support for my nomination and appointment as president of CAHN/ACHN for the coming two years; it is a great honour to be awarded this position. Thank you also to all who have agreed to hold positions on our Board and Executive committees and to everyone who helped to make the recent joint CAHN/CSHM conference at Congress in Victoria such a success!

My more formal introduction to the role of president of CAHN/ACHN came at the recent joint conference of CAHN/ACHN and CSHM at the Congress of the Humanities and Social Sciences at the University of Victoria this past June. There, a number of important ideas were generated to promote scholarship and research in the history of nursing. These ideas included, but were not limited to, exploring new avenues of funding for nursing history research, and the idea of re-examining our relationship with the Canadian Society for the History of Medicine (CSHM). While this topic has been raised before, this year we moved forward to appoint two members from each of our associations (CAHN/ACHN and CSHM) who will form a working group to look into options for a change in the relationship between our two organizations. This group will report their findings and suggestions at next year's AGM at the CAHN/ACHN conference at York University with follow-

up for more formal suggestions at our next joint conference.

Another important development was announced by Dr. Geertje Boschma from UBC, representing the newly establish Consortium for Historical Inquiry in Nursing and Healthcare. This newly established consortium will help facilitate research and scholarship in nursing history across Canada and is a very exciting development for nursing historians who, speaking for myself, often feel isolated at the far western coast of this very large country.

One topic that I would particularly like to ask for your ideas about generating new membership. If you have some novel ways that we could advertise our association or novel venues that we could promote membership through, I would love to hear about them--please email me! Also, don't forget to spread the word about our Vera Roberts Award and Margaret Allemang Scholarship to students and researchers in nursing history within your community – these awards are generous and they benefit both the student/researcher and as a consequence, those who are passionate about the history of nursing.

## Update from the Canadian Network of Nursing Specialties

## The Consortium for Historical Inquiry in Nursing and Health Care

Recently the School of Nursing at UBC established a Consortium for Historical Inquiry in Nursing and Health Care with generous support from patron and Associate Professor Emerita Helen Shore. The consortium is led by faculty member Dr. Geertje Boschma. It aims to bring together students, faculty, members from the UBC scholarly community, such as the UBC library, as well as members from the wider community to support the development of knowledge and resources in nursing and health care history. # News from Medicine Hat College

## CREATING A LASTING LEGACY.....

One thing was clear to anyone who knew Ron Rodgers – Willma was the light of his life.

Willma, his wife of 33 years, passed away more than a decade ago but he never forgot his commitment to honour her with a lasting legacy. A \$2.2 million bequest to Medicine Hat College in Willma's name will benefit the Division of Health Studies for years to come.

The agreement states the money will be used as an endowment. The interest earned will go towards assisting students with bursaries and programming costs within the division.

The donation came as a surprise to MHC's foundation as Rodgers had left no prior indication to the foundation office of a planned bequest.

But for Rodgers' niece Jennifer Ericson, the legacy donation couldn't be more fitting for a "quiet, gentle man whose wife was the light of his life."

"He was very proud of Willma's career in nursing. She worked hard and was successful in her nursing career in an era when many women left the workplace once they married," said Ericson.

The couple had a fairy-book love story. Both Willma and Rodgers were born in Scotland but didn't meet until emigrating to Canada separately. Rodgers joined the navy after school and travelled the world as an engineer before settling in Canada in the late 1950s.

Willma's passion was always caring for others. She completed her nursing training at

Dundee Royal Infirmary, specializing in maternity care and winning the Dr. Marion Kirkland Prize for nursing ability.

Willma's adventurous spirit led her to South Africa, where she worked in Johannesburg for two years. A few years later she capitalized on a vital need for nurses in booming Saskatchewan and in the mid-60s, met Rodgers on a blind date.

"For Ron it was love at first sight and they were married in 1966," said Ericson.

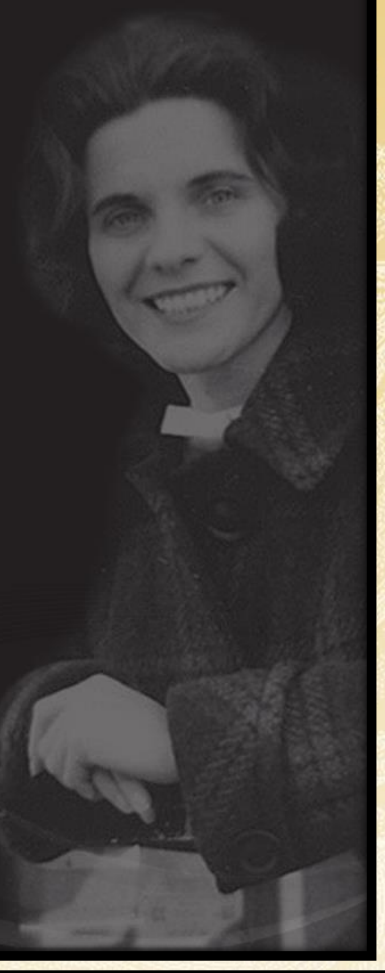
They settled in Manitoba and lived a happily married life for more than 30 years. In the early 1990s they retired to Medicine Hat until Willma's passing from ovarian cancer in 1999 at the young age 65. Ericson said Ron never got over the loss of Willma. He passed away in 2011 at the age of 89.

"He did not feel the need to have lots of people around but enjoyed conversation and had some wonderful stories," Ericson recalled of her uncle. "He worked hard throughout his life and was not extravagant – he always lived within his means and saved for the future."

This financially responsible way of living allowed him to leave a lasting legacy for the benefit of countless future students.

"The fact that his legacy is in Willma's name is a testament to his lifelong devotion to his wife and his own humility," said Ericson. "He and Willma both appreciated the greater good to be accomplished from saving and donating money rather than spending it on themselves.

I know Ron will have had a great deal of comfort before he died knowing about his gift in Willma's name – for him that would have been priceless."

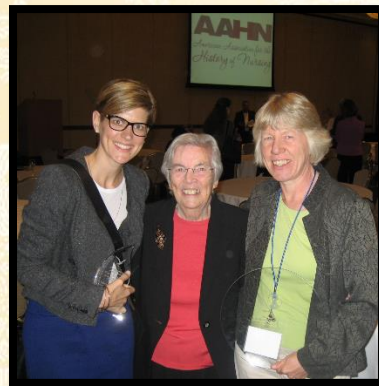

## Congress of the Humanities and Social Sciences, Canadian Association for the History of Nursing Conference 2013

The 2013 Congress of the Humanities and Social Sciences at the University of Victoria, June 1-9, was one of the largest Congresses in its 82- year history. There were over 7,600 delegates and 68 participating associations presenting, including the joint meeting of the Canadian Association for the History of Nursing and the Canadian Society for the History of Medicine. ### Highlights

#### Costume Event

For many, the first event of the Congress was *Dressing Up History: A Costume Parade*, organized and presented by nursing historians and scholars, Sheila Zerr and Glennis Zilm of Vancouver. Sheila and Glennis are active members of the BC History of Nursing Society (<http://www.bcnursinghistory.ca/>). According to Dr. Zilm, “the study of attire worn by nurses throughout the ages reveals a great deal not only about nurses’ struggles for professional status and recognition but also about their relationships with their contemporary society, about their independence or dependence, and about their roles. Interestingly, study of nursing costumes reveals that nurses occasionally have been in the forefront of women’s fashion and change.” There were at least 70 people present for this event, including many student and faculty volunteers from Victoria, Vancouver, and up-island, also including our acting director of the School of Nursing at UVic, Anne Bruce, and her mother Sophia Bruce, also a retired nurse.

### Welcoming CAHN and CSHM members

The same evening as the costume event, CAHN conducted its annual Board Meeting, and the following morning, the joint conference opened with a welcome to Congress from Dean of Human and Social Development, Mary Ellen Purkis, followed by CAHN President Beverley Hicks and CSHM President Susanne Klausen.

### Hannah Lecture

At mid-morning, Dr. Hicks welcomed Hannah Lecturer Barbara Mann Wall, Associate Professor of Nursing and the Associate Director of the Barbara Bates Center for the Study of the History of Nursing at the University of Pennsylvania. Dr. Mann Wall presented: "Disasters, Nursing, and Community Responses: A Historical Perspective." The focus of this presentation was the role and leadership of nurses during past disaster responses. Using primary and secondary archival sources and journals, Mann Wall explained that while nurses, "dealt with massive destruction and death, they did so in ways that restored a sense of order in the aftermath of a chaotic tragedy" (CAHN/CSHM Programme Abstract, June, 2013). And yet, according to Mann Wall, the value of healing stories, the blurring of professional boundaries, and the presence of racial pathologizing during these responses, has not yet been fully explored within the context of nursing history.

### Student Presentations

Following Dr. Mann Wall's lecture, CAHN student delegates attended a graduate student lunch, hosted by CSHM. Here, students and senior historians shared a meal and discussed their work and ideas. Of these students, Heather Graham, Catherine Haney, Margaret Scaia, Brandi Vanderspank, Dana Walsh, and Whitney Wood presented at the conference (see the programme posted on this newsletter site for full abstracts of these and all other presentations). Thank you to students and their mentors for sharing your scholarship!

### CAHN Annual AGM

#### Exploring new relationships between CAHN and CSHM

On the second day of our joint conference CAHN conducted its annual AGM (see posted minutes of this meeting in this newsletter). Highlights of that AGM included the president's report in which Beverley Hicks explained that at the CSHM AGM the previous day, a motion had been put forward to name two people to a task force to examine the future of the relationship between CSHM and CAHN. Hicks then put forward a similar motion on behalf of members of CAHN. Geertje Boschma and Ann-Marie Arsenault were nominated to serve as CAHN's representatives. It was also suggested that the outgoing presidents of CAHN and CSHM act as *ex officio* members of the committee to facilitate communication between the two organizations. The task of this joint working group will be to prepare a discussion paper to be presented at the 2014 Annual General Meeting, and a final report including any proposals and by-law amendments, to be presented at the 2015 CAHN AGM.

### Vera Roberts Award

As a result of deliberations by the Research Committee and board members of CAHN, it was announced that the Vera Roberts Award for 2013-2014 will be allocated for an international conference on northern nursing. Watch for details on our website!

### Book Launch

The same day as the AGM, June 2<sup>nd</sup>, CSHM hosted a book launch and champagne reception in one of the main lecture halls of the conference. Strawberries dipped in chocolate and sparkling wine accompanied the two minute presentation of each author's book, which included *A Cultural History of the Nurse's Uniform* by Christina Bates. Attendees of the book launch and others who had registered for dinner at the University Club on the UVic campus, then proceeded to enjoy a dinner among friends and colleagues.

### Segal Prize

The following day, more presentations followed, capped by the presentation of the Segal Prize to David Theodore, of Harvard University. David's presentation at Congress was titled, "*Planning for the Patient: Patient-centered Care and Automation.*" Congratulations David! Finally, later in the afternoon, Victoria Historian John Adams took a small group on a medical historical walking tour of downtown Victoria that was an eclectic mix of cultural medicine traditions, architecture, politics, and social history....his specialty!

Thank you to all who attended the CAHN/CSHM conference – it was my pleasure to see old friends and to meet new ones – I look forward to the coming year and getting to know more about your ideas for CAHN. Thank you to outgoing president Beverley Hicks for all her generous mentorship! -Margaret

### 2014 Call for Abstracts

The Canadian Association for the History of Nursing /Association Canadienne pour l'Histoire du Nursing Annual Conference will be held June 13-15, 2014 at York University, Toronto, Canada. The theme for the 2014 conference is **Local Work, Global Health and the Challenge of Transnational Nursing**. The Abstract Committee is particularly interested in papers focusing on nursing in transnational, international and global contexts, but will, of course, welcome papers on all nursing history topics. Please note that the Abstract Committee will consider submissions of panels in addition to individual papers.

The Hannah/AMS Lecture will be delivered by Dr. Juanita De Barros of McMaster University Department of History. Dr. De Barros has authored and edited numerous volumes, including her first monograph *Order and Place in a Colonial City: Patterns of Struggle and Resistance in Georgetown, British Guiana, 1889-1924* (McGill-Queen's University Press, 2002) as well as *Health and Medicine in the Circum-Caribbean, 1800-1968* (co-edited with David Wright and Stephen Palmer, Routledge, 2009.) Her current research examines maternal and infant health policy in the British Caribbean.

This anthology brings together a series of essays on transnational themes and methodological approaches pertaining to the historical study of global health, welfare and humanitarianism. The essays on topics ranging from missions to methods offer a more nuanced understanding of the interconnectedness and evolving nature of global charitable work, as well as its contribution as an historical antecedent of contemporary (secular) notions of ‘global citizenship’ and global health. Written by and about northern Europeans and North Americans interested in transnational knowledge exchanges in Africa, Asia and the Middle East, these essays reflect the complex ways in which both historians and their subjects transverse(d) national, gendered, racial and religious boundaries. Through them, the authors open up new questions about the nature of transnationalism (and transnational research) itself.

### **Lyle Creelman: The Frontiers of Global Nursing** *Susan E. Armstrong-Reid*

This intriguing scholarly biography examines the important contributions of Canada’s foremost international nurse, Lyle Creelman. Creelman parlayed her experience as a community health nurse in British Columbia into significant international appointments with two organizations undertaking massive responsibility for health tasks in the post-war period – first, as chief nurse of the British Zone of Occupied Germany with the United Nations Relief and Rehabilitation Administration (UNRRA), and, from 1954 to 1968, the Chief Nursing Officer of the World Health Organization (WHO).

## Rethinking Unequal Exchange: The Global Integration of Nursing Labour Markets

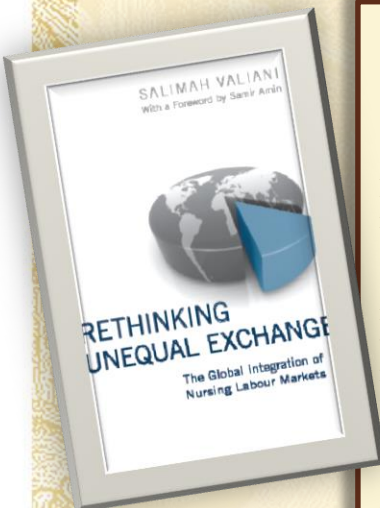
*Salimah Valiani*

Rethinking Unequal Exchange traces the structural forces that have created the conditions for the increasing use, production, and circulation of temporary migrant nurses worldwide.

Salimah Valiani explores the political economy of health care of three globally important countries in the importing and exporting of temporary migrant nurses: the Philippines, the world's largest supplier of temporary migrant nurses; the United States, the world's largest demander of internationally trained nurses; and Canada, which is both a supplier and a demander of internationally trained nurses. Using a world historical approach, Valiani demonstrates that though nursing and other caring labour is essential to human, social, and economic development, the exploitation of care workers is escalating. Valiani cogently shows how the global integration of nursing labour markets is deepening unequal exchange between the global North and the global South.

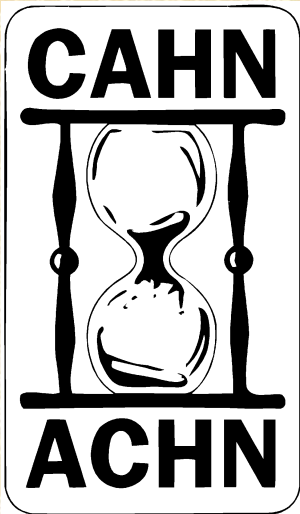
