A group of influenza historians and anthropologists will discuss the ways in which historical knowledge about the 1918-19 influenza pandemic is employed (or, not employed) in current debates about the impact of the influenza virus and public health responses. What elements of influenza's history are taken up by today's society, in what ways? What aspects of influenza history are downplayed or ignored? Themes in the roundtable discussion will include gender and volunteer caregiving; First Nations experiences; social inequality and access to health care; discourses of fear and personal responsibility; international public health discourse; and the "lessons" influenza history brings to current public health practices.
